1. Who We Are

2. Information We Collect

We may collect the following types of information:

- **Contact information** — name, email address, phone number, mailing address
- **Event registration details** — attendance preferences, session selections
- **Communication preferences** — opt-in status for SMS, email, and other communications
- **Usage data** — website browsing activity, page visits, form submissions
- **Device/browser data** — IP address, browser type, operating system (collected automatically)

3. How We Use Your Information

We use the information we collect to:

- Register and communicate with event attendees
- Send appointment reminders, event updates, and logistics
- Provide customer support and respond to inquiries
- Send promotional messages about upcoming Medicare Expo events (with your consent)
- Improve our website and event offerings
- Comply with applicable laws and regulations

4. SMS / Text Message Communications

SMS Consent & Communication Notice

By providing your mobile phone number and opting in, you consent to receive text messages from Medicare Expo LLC, including event reminders and appointment confirmations, promotional announcements about upcoming Medicare Expo events, and customer service and support responses.

Message and data rates may apply. Message frequency will vary based on your interactions and upcoming event schedules.

We retain your personal information for as long as necessary to fulfill the purposes described in this policy, or as required by law. You may request deletion of your data at any time by contacting us.

7. Your Rights

Depending on your location, you may have the right to:
